

ARTICLES OF INCORPORATION

OF

NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC29

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, being over the age of twenty-one (21) years, for the purpose of forming a corporation under Chapter 11 Title 30 of the Idaho Code, State of Idaho Religious, Social And Benevolent Associations, do hereby adopt in triplicate the following Articles of Incorporation.

ARTICLE I.

The name of this corporation is and shall be, NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The purpose or purposes for which this corporation is organized are as follows, viz:

1. For ourselves, our children and our neighbors, a peaceful, social, Christian, orthodox, evangelical organization teaching temperance, morality, love of God (who sent his son to die for the sins of mankind), love of Christ (who died for us), love of humanity, and love and respect for our Nation, our State and our City; and also,

2. To define the powers and the business of the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. as set forth in a Constitution of the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. to be adopted on or before one year from the date of this incorporation, which Constitution shall produce and secure a uniform mode of action in faith and practice, and,

3. To engage in generally and carry on any lawful business which may, in the judgment of the Board of Directors, at any time be necessary, useful or advantageous to the corporation.

4. In furtherance of and not in limitation of the general powers conferred by the laws of the State of Idaho, it is expressly provided that this corporation shall also have the following powers:

(a) To borrow money and give security therefor.

(b) To enter into, make, perform and carry out contracts of every kind for any lawful purposes pertaining to its business with any individual, entity, firm, association, or corporation, or with any governmental, municipal, or public authority, domestic or foreign.

(c) To do everything necessary, proper, convenient or incidental to the accomplishment of the purposes and objects of this corporation, or which is calculated directly or indirectly to promote the welfare or interests of the corporation or enhance the value of any of its property or rights.

(d) To do any and all of the things in this article set forth to the same extent a natural person might or could do, and in any part of the world, as principals, agents, contractors, trustees, or otherwise, either alone or in company with others.

ARTICLE IV.

The following provisions, not inconsistent with law, shall be applicable for the regulation of the internal affairs of this corporation:

1. Membership in the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. shall be without cost.

2. NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. has a representative form of government.

3. The voting membership of the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. shall consist of all who have been organized as a church by membership and each shall have equal voting rights in the election of directors to conduct the business of the church.

ARTICLE V.

The address of the initial registered office of the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC. is 912 7th Avenue, Lewiston Idaho, 83501, and the name of the initial registered agent at such address is: Asa M. Calvert.

That on the 22nd day of July A.D. 1978 and once a week for two consecutive weeks thereafter, there was published in the Lewiston Morning Tribune, a newspaper of general circulation, published at Lewiston Nez Perce County, Idaho a NOTICE (Copy attached hereto and made a part of these Articles of Incorporation), giving time and place of the holding of an election of Directors of the NEW LIFE UNITED BRETHREN CHURCH UNTO HOLINESS INC., the last publication thereof being on the 29th day of July, A.D. 1978, and said NOTICE was so published in the regular and entire issue of the said newspaper and not in a supplement thereof and was so published in every issue and number of the said paper, during the period and times of publication as set forth above, and further,
