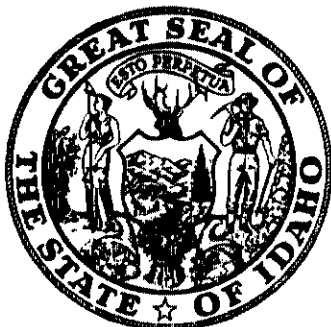
CERTIFICATE OF INCORPORATION OF

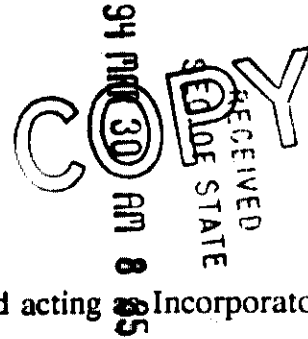

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age and acting as Incorporator of a Corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST:

The name of the Corporation is RAD Products, Inc.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the Corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the Corporation shall have authority to issue is one hundred (100) shares of common stock at the par value of one thousand dollars (\$1,000.00) per share.
