The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SO SHARE-A-HOME, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To operate a shelter home in accordance with Chapter 33, Title 39, Idaho Code and the rules and regulations promulgated thereunder. To acquire, buy, purchase, lease, or otherwise, and to improve and develop real property. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. In general, to do such things as may be necessary or desirable in connection with the foregoing, and for such other purposes as the incorporators may determine.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares common stock with a \$10.00 par value per share.
