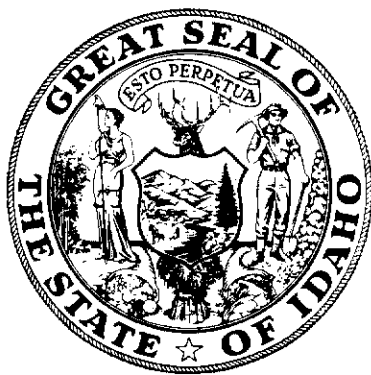

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
BUSINESS ADMINISTRATORS, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, to be effective immediately upon acceptance by the Secretary of the State of Idaho:

FIRST: The name of the corporation currently is BUSINESS ADMINISTRATORS, INC.

SECOND: That the following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation at a special meeting of all of the shareholders entitled to vote thereon, on February 10, 1987, as prescribed by the Idaho Business Corporation Act:

Article Four of the Articles of Incorporation of BUSINESS ADMINISTRATORS, INC., is hereby amended to read as follows:

"FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 at the par value of \$1.00 per share."

THIRD: The number of shares of the corporation outstanding at the time of such of adoption was 100. The number of shares entitled to vote thereon was 100, with 100 shares voted for and none voted against the proposed amendment.

FOURTH: The amendment does provide for a change in the amount of stated capital, reducing the stated capital of the

corporation from \$10,000.00 to \$500.00.


