ARTICLES OF INCORPORATION
OF
JOHN B. DRIPS GOLF PROFESSIONAL, INC.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is JOHN B. DRIPS GOLF PROFESSIONAL, INC. (hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in any lawful act; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be P. O. Box 845, McCall Golf Course, McCall, Idaho 83638, and the name of its initial registered agent at such address is John B. Drips.

ARTICLE V

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be authoized to issue shall be ten thousand (10,000) shares of stock, each having a par value of \$1.00 per share. All shares of stock shall have the same rights in such Corporation and shall be nonassessable when paid in full.

ARTICLE VI
