The name of the non-profit organization is the Idaho Candlelighters Foundation, Inc.

The Idaho Candlelighters Foundation, Inc. is a non-profit organization.

The period of duration shall be perpetual.

The Idaho Candlelighters Foundation, Inc. is a parent-support group for parents whose children have or have had cancer. We will provide mutual support for each other during a very stressful time. We will help the American Cancer Society in educating the public as to facts and myths of childhood cancer. We will help provide financial assistance to those families in need.

The affairs of the Idaho Candlelighters Foundation, Inc. will be run by the Executive Committee, consisting of parents and representatives from American Cancer Society, Mountain States Tumor Institute, and Intermountain Youth Cancer Foundation, all volunteers. The members may change from time to time.

The Idaho Candlelighters Foundation, Inc. is organized exclusively for charitable, supportive, and educational purposes.

No part of the net earnings of the Idaho Candlelighters Foundation, Inc., shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in futherance of the purposes set forth in Article four hereof. Notwithstanding any other provision of these articles, the Idaho Candlelighters Foundation, Inc., shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Upon the dissolution of the Idaho Candle lighters Foundation, Inc., the Executive Committee shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or supportive purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Executive Committee shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes of to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
