AMMENDMENTS TO ARTICLES OF INCORPORATION OF THE BRIDGE, INC.

MAI 21 12 58 PM '86
MEMBERS OF THE CORPORATION
At a duly called meeting of the Board of Directors of THE BRIDGE, INC. on
5/19/86 do amend the Articles of Incorporation as follows:

AMMENDED ARTICLE IV

The purpose of this Corporation shall be a refuge for the treatment, education, rest and rehabilitation of persons afflicted with alcoholism and other dependencies. THE BRIDGE, INC. has been established exclusively for benevolent, educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE IX

In the event of dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. All existing debts and obligations of the organization shall be paid prior to dissolution.
