ARTICLES OF INCORPORATION, STATE OF IDAHO
OF
HMS, INC.

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be HMS, INC.

ARTICLE II

The purposes for which said corporation is formed are:

A. To provide management, accounting, supervisory, and support services to providers of medical services and related health industry organizations; to own, operate, lease, sell and otherwise deal with medical equipment, computers, and any equipment or machinery related to the providing of services as above set forth.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

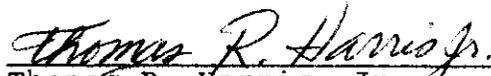

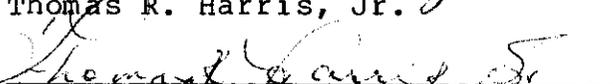
