ARTICLES OF INCORPORATION

OF

QUEEN BEE FLIGHTS, INC.

The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be Queen Bee Flights, Inc.

ARTICLE II

PURPOSE

The purpose(s) for which this corporation is organized are:

- (1) To provide flight training at all levels to students and to rated pilots who want additional training; and to provide any commercial flight application covering flight training, commercial operations, or taxi, etc.
- (2) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE III

PLACE OF BUSINESS AND AGENT

The registered office of this corporation and the principal place for the transaction of its business is hereby designated as Rigby,

Idaho. The name of the registered agent is Charles A. Kemper, Route #1,

Rigby Airport, Rigby, Idaho 83442, at that address.

ARTICLE IV

EXISTENCE

The corporation shall have perpetual existence.

ARTICLE V

CAPITAL

The capital shall be evidenced by 100,000 shares having a par value of \$1.00 per share so that the capital shall be \$100,000. This stock shall be issued pursuant to Section 1244 of the Internal Revenue Code.

Such stock is, and shall remain, nonassessable.

ARTICLE VI

NO LIABILITY

The private property of the stockholders of this corporation shall not be subject to the payment of corporation debts to any extent what-soever.

ARTICLE VII

AMENDMENT

The Directors, by a two-thirds (2/3) vote, may repeal, amend and/or adopt new By-Laws, which By-Laws may be further repealed, amended and/or adopted by the shareholders by a two-thirds (2/3) vote of all issued and outstanding shares. In the event of an amendment by the shareholders, said By-Laws so amended cannot thereafater be repealed or amended by the Directors.

ARTICLE VIII

CAPITAL STOCK
