1. NAME. The name of the corporation is Wheeler CPA, PC.

2. <u>AUTHORIZED SHARES</u>. The aggregate number of shares this professional corporation is authorized to issue shall be 1,000 with a par value of \$1.00 per share, all of which shall be common voting stock and shall not be subject to assessment.
