The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Guerry Brothers Farms, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to the growing, purchasing, and marketing of all types of agricultural commodities and livestock.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is  $653 \ E \ 3800 \ N$ , Buhl, Idaho, 83316, and the name of its initial registered agent at such address is Michael A. Guerry.

SIXTH: Provisons for the regulations of the internal affairs of the corporation are: There shall be no Board of Directors for the corporation. The Shareholders of the corporation shall be responsible for the regulation of internal affairs of the corporation.
