CERTIFICATE OF INCORPORATION

I, JAS H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

GLAD TIDINGS ASSEMBLY, INC.

was filed in the office of the Secretary of State on the 29th day of December A. D. One Thousand Nine Hundred Fifty-eight and is duly recorded on Film No. 105 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Boise in the County of Ada and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
"GLAD TIDINGS ASSEMBLY, INC."

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, LYSLE COOK, RUBY G. EVANS, EDITH G. ALEXANDER AND ROBERT J. BARNETT, being natural persons of legal age and citizens of the United States of America, and members of a church and religious organization, do hereby, in accordance with the rules, regulations and discipline of such church and religious organization, associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and we do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I

The name of said corporation shall be "GLAD TIDINGS ASSEMBLY, INC."

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The location and post office address of its registered office and principal place of business shall be Boise, Ada County, Idaho.

ARTICLE IV

The purposes for which this corporation is formed are:

1. To operate and maintain a Glad Tidings Assembly Church in the town of Boise, Idaho; to promote religious worship; to teach and preach the Word of God; to establish and maintain a place of worship and teachings for the meetings of the church; to carry on and conduct missionary, educational and charitable work.

2. To print, distribute and circulate literature of a religious nature.

3. To purchase, own, hold, lease, sell, convey, mortgage, or otherwise hypothecate real estate and personal property of all

kinds and descriptions necessary or incident to or in connection with its church work.

4. To erect buildings and other structures necessary and proper for the carrying out of the purposes above mentioned; to borrow money and to do any and all other things whatsoever which may be requisite and necessary and proper in and about the carrying out of the purposes and objects for which this corporation is organized.

ARTICLE V

Pecuniary profit is not the object of this corporation, and there is no capital stock and there are no shares of stock.

ARTICLE VI

The number of Directors and Trustees for the incorporation of this corporation shall be four (4).

ARTICLE VII

The Trustees and Directors of this corporation shall not be less than three (3) nor more than twelve (12) and the names of those who shall manage the affairs of the corporation until the election of their successors are, namely: LYSLE COOK, RUBY G. EVANS, EDITH G. ALEXANDER AND ROBERT J. BARNETT.

CERTIFICATE

Pursuant to notice as required by law, an election at 523 Sierra Drive, Boise, Idaho, for the election of four (4) said Directors and Trustees for the incorporation thereof, was held by the members of the Glad Tidings Assembly, on the 14th day of

December, 1958, at 7:30 o'clock p.m. of said day, and a notice of said election was duly published in the Idaho Daily Statesman on December 1, 1958 and December 8, 1958, posted as required by the laws of the State of Idaho in such cases made and provided, and that the persons above named, namely: Lysle Cook, Ruby G. Evans, Edith G. Alexander and Robert J. Barnett were duly elected Directors and Trustees at said election by a majority of the members of said Church organization for the incorporation of said Church and voted for at such election for two years or until the election and qualification of their successors. Robert L.J. Barnett, of said Church, presided as Chairman of said meeting and Edith G. Alexander, a qualified member of said Church, acted as Secretary.
