




CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF OF IDAHO,

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PIONEER CAR RENTAL OF IDAHO, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is for car rental, sales, leasing of cars, etc., together with any other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is TEN (10) shares of common stock, with no par value.

FIFTH: This corporation shall be a closely held corporation.

SIXTH: The By-Laws of the corporation shall provide for a restriction on transfer of stock that provides the corporation with a first-purchase option upon such transfer.

SEVENTH: No one person and that person's spouse, if any, shall together own more than

a fifty percent voting interest in corporate stock in the corporation.

EIGHTH: The address of the initial registered office of the corporation is 706 North 1st Street, McCall, Idaho, 83638 and the name of its initial registered agent at such address is Steven J. Millemann.

NINTH: The number of directors constituting the initial board of directors of the corporation is two (2) and the names and addresses of the persons who are to serve as directors until the first meeting of the shareholders, or until their successors are elected and shall qualify, are:
