

Pursuant to Idaho Code 30-1-58 and 30-1-61, I, the undersigned, Incorporator of Clean Check, Inc., file the following amendments, which were unanimously adopted by the Incorporator on January 25, 1995.

1. The current name of the corporation is Clean Check, Inc., in accordance with Paragraph 1 of the Articles of Incorporation.

2. The amendments so adopted changes Paragraph IV of the Articles of Incorporation filed with the Secretary of State in Idaho on January 23, 1995, which reads: "The aggregate number of shares which the corporation shall have authority to issue is 200,000. The shares shall have no par value." shall be changed to read: "The aggregate number of common shares which the corporation shall have authority to issue is 200,000, of which 10,000 shall have voting rights and 190,000 shall not have voting rights. The shares shall have no par value."

3. The date of the adoption of the amendments by the Incorporator was January 25, 1995.

4. As of this date, January 25, 1995, the corporation has not transacted business of any nature or issued any of its shares.


