



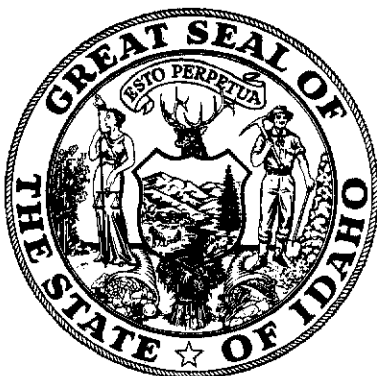
CERTIFICATE OF INCORPORATION

The undersigned, acting as Incorporators of a Corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

I.

The name of the Corporation is BLA BAR, INC.

The period of its duration is perpetual.


