**Articles of Incorporation  
of**

**Basic Community Concepts, Inc.**

The undersigned, acting as incorporators of a Cooperative Corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for this cooperative corporation:

**I.**

The name of this corporation shall be Basic Community Concepts, Inc., a nonprofit corporation.

**II.**

The period of existence and duration of the life of this corporation shall be perpetual.

**III.**

The address of the initial registered office of this corporation is 1227 11th Ave. E., Twin Falls, Idaho 83301. The name of the initial registered agent at such address is Stephen E. Tanguy.

**IV.**

The purposes of this corporation are:

- To provide management for and assistance in the development of direct marketing opportunities for small businesses engaged in the production and sales of produce, food items, crafts, and other agriculturally related items within a limited geographical area
- To provide and promote educational, cultural, and community activities.

This corporation may transact any or all lawful business for which cooperative corporations may be incorporated under the Idaho Business Corporation Act.

**V.**

The officers of the corporation shall consist of at least a President and a Secretary. These two offices may not be held by the same person.

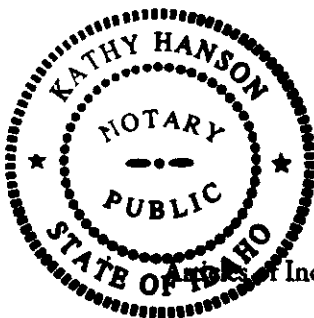
