## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corp[oration under the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

#### Article 1.

The name of the corporation is Idaho Commercial Construction Company.

#### Article 2.

The period of its duration is perpetual.

#### Article 3.

The corporation is organized for the purpose of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### Article 4.
