RECOMPALL PERSONS OF THESE PRESENTS: that the foldowing named and undersigned natural persons of full age and citizens of the United States of America, hereby associate ourselves accepther for the purposes of forming a non-profit corporation under the provisions of Chapter 3, Title 30, Idaho Code, and do hereby certify as follows:

#### ARTICLE ONE: NAME

The name of this corporation shall be IDAHO HAY ASSOCIATION, INC.

#### ARTICLE TWO: NON-PROFIT STATUS

This corporation is a non-profit corporation and is organized to comply with the purposes and meanings of Section 501 (c) (3) of the Internal Revenue Code.

#### ARTICLE THREE: PURPOSE

The purpose of this corporation is to promote and foster the welfare of the hay industry in the State of Idaho.
