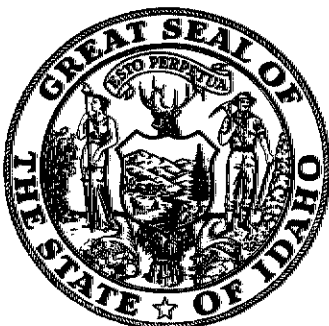

The undersigned, acting as incorporators under the provisions of the Idaho Business Corporations Act, adopt the following **Articles of Incorporation.**

NAME

The name of the corporation is **CUSTOM MILLWRIGHT AND CONSTRUCTION Inc.**

DURATION

The period of its duration shall be perpetual.

PURPOSES

The purpose for which the corporation is organized is the transaction of any and all lawful business fore which corporations may be incorporated under the Idaho business Corporation Act, and its initial business activity shall consist primarily of commercial and residential construction and sales.
