KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned incorporator being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and very these Articles of Incorporation.

# ARTICLE I

The name of the corporation is CARIBOU, INC.

#### ARTICLE II

The period of its duration is perpetual.

# ARTICLE III

The purposes for which the corporation is organized are as follows:

- (a) To engage in the business of electrical power facilities construction and contracting;
- (b) To undertake all other business activities of any kind or nature for which businesses may be lawfully incorporated under the laws of the State of Idaho;
- (c) To do all other things necessary or incidental to the foregoing business purposes.

# ARTICLE IV

The corporation is authorized to issue one class of shares, in a total amount of 1,000 shares. The stock shall bear no par value.
