ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of a corporation (the "Corporation") organized pursuant to and subject to the Idaho Business Corporation Act; Chapter 1, Title 30, <u>Idaho Code</u> (the "Act"), adopts the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME
