ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a nonprofit corporation organized under and pursuant to the Idaho Nonprofit Corporation Act, Section 30-3-17, Idaho Code, adopts the following Articles of Incorporation.

ARTICLE I. - CORPORATE NAME

The name of the Corporation shall be "THE IDAHO FALLS INC". This CHRISTIAN ACADEMY, name satisfies the requirements of the Idaho Nonprofit Corporation Section 30-3-27, Idaho Code.

ARTICLE II. - PURPOSES OF CORPORATION

The purposes for which the Corporation is organized and will be operated are as follows:

- The Corporation is organized exclusively for charitable, religious, and educational purposes, including purpose of encouraging and providing Christian-based education for students in grades seven through twelve.
- The purposes for which this charitable nonprofit Corporation is organized shall be limited to only those charitable, religious, and educational purposes, which

allow it to qualify as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.

• To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

ARTICLE III. - DIRECTORS

The affairs of the Corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation's Bylaws. Each Director of the Corporation shall, at all times, be a member of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected by the existing Directors of the Corporation in the manner and for the term provided in the Bylaws of the Corporation.

ARTICLE IV. - INITIAL REGISTERED AGENT

The location of the Corporation is in the City of Idaho Falls, County of Bonneville, State of Idaho. In compliance with Idaho Code, Section 30-1-501, the name of the initial registered agent of the Corporation named to receive service of process on behalf of the Corporation if litigation should occur is Carolyn Harrison, whose address is 2971 East, 97th South, Idaho Falls, Idaho, 83406.

ARTICLE V. - INCORPORATOR

The name and street address of the incorporator is Gene Lund, 346 Carol Avenue, Idaho Falls, Idaho, 83401.

ARTICLE VI. - MEMBERS OF CORPORATION

The Corporation shall have no members.

ARTICLE VII. - DISSOLUTION OF CORPORATION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to Christian evangelical religious nonprofit corporations or organizations for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or

local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the district court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII. - PERIOD OF DURATION

The period of duration of the Corporation shall be perpetual.

ARTICLE IX. - DISTRIBUTION OF EARNINGS OR ASSETS

No part of the net earnings or the assets of Corporation shall inure to the benefit of, distributable to, its members, directors, officers, other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.
