
### CERTIFICATE OF INCORPORATION OF

**ARTICLE 1, Name:**

The name of the corporation shall be "Eagle's Nest Christian Fellowship, Inc." STATE OF IDAHO

**ARTICLE 2, Purpose:**

SECTION 1. To establish and maintain places of worship of the only true God, to expound the scripture, to exalt the Lord Jesus, to honor the Holy Spirit, to spread the good news according to the teaching of Jesus and the apostles, and to promote the furtherance of the gospel and the kingdom of God in the United States of America and foreign countries.

SECTION 2. To promote and maintain churches and missions in the state of Idaho, the United States, and foreign countries, and to provide fellowship and means of cooperation between churches of similiar faith and doctrines.

SECTION 3. To promote freedom of worship and liberty of expression, within the limits of it's own statement of faith and doctrine, among it's own members.

SECTION 4. To ordain, license, and otherwise qualify ministers to preach the gospel and provide credentials for the same, as outlined in the bylaws.

SECTION 5. To engage such employees as may be necessary to perform the duties involved in carrying on the corporate business.
