KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all of legal age, and citizens of the United States of America, over the age of twenty-one (21) years, do, under and in pursuance of the general corporation laws of the State of Idaho, and particularly Section 30, Chapter 3A, Idaho Code, hereby organize, constitute and associate ourselves and such other persons as may hereafter become associated with us, for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby adopt and certify the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

ARTICLE I.

That the name of this corporation shall be PREGNANCY COUNSELING CENTER, INC.

ARTICLE II.

That the location and post office address of the registered office in the State of Idaho shall be 1448 "G" Street, Lewiston, Nez Perce County, Idaho. The name of the registered agent is Del Steiner, 1448 "G" Street , Post Office Box 1124, Lewiston, Nez Perce County, Idaho.

ARTICLE III.

That the duration and term of existence of this corporation shall be perpetual.

ARTICLE IV.

That in furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

Preserving the sacredness of life; aiding the expectant mother in all phases of her pregnancy and immediately after the birth of the child if desired by the mother; and helping to make understandable and appreciated the value of the life of the child and dignity of the mother.

To expand the awareness of the dignity, the individuality, and the infinite value of every life; through educational activities, to inform human beings of the positive alternatives as to the personal and social problems

relating to human pregnancy; educating the public as to these positive alternatives and any other powers necessary to carry out its purposes.

To acquire, own, hire, invest in, lease and provide facilities consisting of both real and personal property, equipment, and gear in furtherance of the powers, objects and purposes.

To do all things in connection with its objects permitted by law and to exercise any and all powers not prohibited by law as pertains to organizations of this type.

ARTICLE V.

This corporation is not organized for profit and shall have no capital stock, and shall be composed of members rather than shareholders in accordance with the foregoing provisions.

ARTICLE VI.

The conditions and regulations of membership and the rights and privileges of members shall be determined and fixed by the Bylaws.

ARTICLE VII.

The private property of the members shall not be subject to the payment of the corporate debts, liabilities or obligations to any extent whatsoever.

ARTICLE VIII.






