

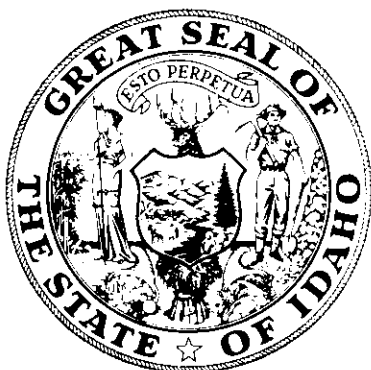
CERTIFICATE OF WITHDRAWAL
