The undersigned, acting as the incomporation of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. The name of this corporation is Sigma Chi Alpha House Corporation.
- 2. The purposes of this corporation is to maintain and conduct a society, the general object of which shall be to cultivate fraternal relations among the alumni and active members of the Sigma Chi Fraternity, the Sigma Chi Alpha Fraternity located at Albertson College of Idaho, Caldwell, Idaho, and its successor chapter upon installation as an undergraduate chapter of the Sigma Chi Fraternity; to advise and cooperate with the active Chapter in all matters pertaining to the welfare of the Chapter; to buy, own, hold, lease, sell and convey such real and personal property as may be necessary or desirable in carrying out the full purpose of the corporation; and, in general, to advance and promote the interest of the Sigma Chi Fraternity.
- 3. This corporation is a nonprofit corporation formed and operated under "The Idaho Nonprofit Corporation Act," Title 30, Chapter 3, of the Idaho Code and the corporation is formed to engage in any lawful act of activity for which such corporations may be organized under said Act.
- 4. <u>PERIOD OF DURATION</u>: The period of duration of this corporation shall be perpetual.
- 5. MEMBERSHIP: The members of the corporation shall be as set forth in the Bylaws of the corporation as adopted by the board of directors and as the same may be amended from time to time.
