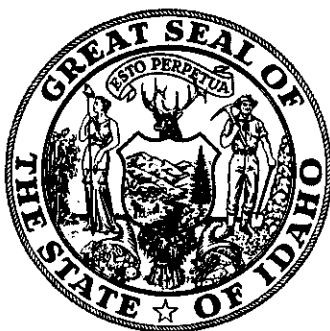
### CERTIFICATE OF DISSOLUTION OF





