ARTICLES OF AMENDMENT

OF

MIRACLE, FAULKNER & BORCHERT, P.A.

Pursuant to Section 30-1-59, Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Article I and Article VII of the Articles of Incorporation are hereby deleted in their entirety and the following substituted therefor:

ARTICLE I

NAME

The name of the corporation from this day forward is **MIRACLE AND ASSOCIATES, CHARTERED.**

ARTICLE VII

GOVERNING BODY

The governing body of this corporation shall consist of a Board of three directors, who shall be elected annually as provided by the By-laws. The number of members of the Board of Directors may be changed from time to time as prescribed by the By-laws, but shall be not less than two nor more than seven. The names and post offices addresses of those who are selected to act as directors until the first annual election are as follows:

Except as modified by this document, the Articles of Incorporation as filed with the Idaho Secretary of State are hereby ratified and affirmed.

SECOND: The number of shares of the corporation outstanding at the time of the adoption of said amendments was 227.52 and the number of shares entitled to vote thereon was 227.52.


THIRD: On the 1st day of November, 1990, pursuant to call and waiver of notice, a meeting of the shareholders of the corporation was held at Mountain Home, Idaho, which meeting was attended by all of the shareholders of the corporation and which meeting was called for the specific purpose of amending Article I and Article VII of the Articles of Incorporation, entitled "Name" and "Governing Body", as set forth above.

FOURTH: At said meeting the foregoing amendment was adopted by the Board of Directors as of the 1st day of November, 1990, and by a unanimous vote of all of the shareholders of the corporation entitled to vote as of November 1, 1990, in accordance with Section 30-1-59 of the Idaho Business Corporation Act.

IN WITNESS WHEREOF, the undersigned, being the shareholders of all the shares of stock in said corporation, have hereunto set their hands in the City of Mountain Home, County of Elmore, State of Idaho, this 6th day of March, 1991.

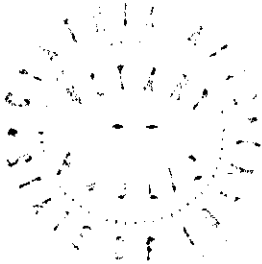
