## ARTICLES OF INCORPORATION

OF

## BIOTECHNOLOGIES, INC.

The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Idaho Business Corporation Act, Idaho Code Section 30-1-1 et seq., adopts the following Articles of Incorporation:

ARTICLE 1. The name of this corporation is BIOTECHNOLOGIES, INC., and its duration shall be perpetual.

ARTICLE 2. The purpose for which the corporation is organized shall be for the conducting of the business of developing and marketing biochemical products and any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE 3. The aggregate number of shares which the corporation shall have the authority to issue is one hundred thousand (100,000) shares common stock, no par value.

ARTICLE 4. The initial By-Laws of this Corporation shall be adopted by the Board of Directors, and such Board of Directors have the power to alter, amend or repeal, or adopt new By-Laws, and such By-Laws may contain any provisions for the regulation and management of the affairs of the Corporation not inconsistent with law or these Articles of Incorporation.
