



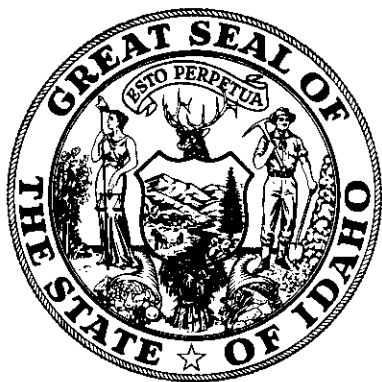

ARTICLES OF INCORPORATION

OF

ARTICHOKE INC.

I THE UNDERSIGNED SUBSCRIBER OF THESE ARTICLES OF INCORPORATION, A
NATURAL PERSON COMPETENT TO RAISE ARTICHOKE, DO HEREBY MAKE, SUBSCRIBE
AND FILE THESE ARTICLES OF INCORPORATION FOR THE PURPOSE OF ORGANIZING A
CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO.

ARTICLE I NAME OF CORPORATION

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE II NATURE OF BUSINESS

THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED BY THIS
CORPORATION SHALL BE: GROWING AND MARKETING ALL OF THE BYPRODUCTS OF
ARTICHOKE, AND TO PROFORM ANY ACT OR THING NOT INCONSISTANT WITH THE LAW,
BUT GIVEING ALL POWERS RELATED TO THE CONDUCT OF SUCH A BUSINESS THAT BE
NEEDFUL AND NECESSARY IN ITS OPERATION. TO HAVE ALL THE RIGHTS, ,POWERS
AND PRIVILEGS INCIDENTAL TO CORPORATION, TOGETHER WITH THE TRANSACTING OF
ANY LAWFUL BUSINESS IN COMPLIANCE WITH THE LAWS OF THE STATE OF IDAHO.

ARTICLE III CAPITAL STOCK
