ARTICLES OF INCORPORATION

ARTICLE I. Name

The name of the corporation shall be Designcraft Seating, Inc.

ARTICLE II. Principal Office

The Board of Directors may from time to time, by resolution, change the location of the principal place of business in Idaho. Section 3. <u>Assessment of Stock.</u> The capital stock of the corporation, after the subscription price has been fully paid, shall not be assessable for any purpose, and no stock issued as fully paid shall ever be assessable or assessed. The holders of such stock shall not be individually responsible for the debts, contracts, or liabilities of the corporation and shall not be liable for assessments to restore impairments in the capital of the corporation.

Section 4. Preemptive Riahts. The shareholders shall have no preemptive rights.

Section 5. <u>Cumulative Voting for Directors</u>. No stockholder of the corporation shall be entitled to cumulative voting of his shares for the election of directors.
