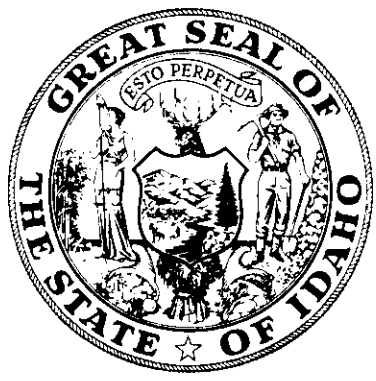

ARTICLES OF DISSOLUTION

OF

ST. MARK'S EPISCOPAL CHURCH OF IDAHO FALLS, IDAHO, INC.

Pursuant to the provisions of Sections 30-1-83 through 30-1-93, Idaho Code, for the voluntary dissolution of a corporation, and acting by resolution duly adopted and consented to by the board of directors, the undersigned corporation does hereby adopt the following Articles of Dissolution:
