First - That the name of the said

Second - That the objects for which
it is formed are to construct and

maintain a water ditch from the Payette River through the Noble ditch in Canyon County State of Idaho for irrigating and other purposes.

Third - That the place where its principal business is to be transacted is Payette State of Idaho.

Fourth - That the time for which it is to exist is fifty (50) years from and after date of its incorporation.

Fifth - That the number of its directors shall be five (5), and that the names and residences of those who are appointed for the first year are.
