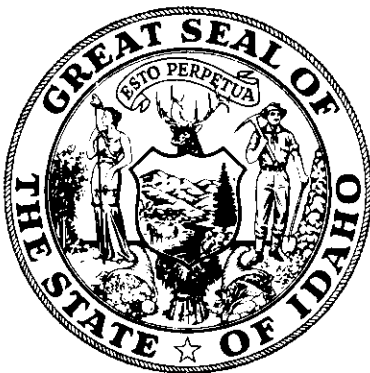

ARTICLES OF INCORPORATION
OF
CALVARY HOLINESS CHURCH, INC.

We, the undersigned, desiring to form a nonprofit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

ARTICLE ONE

NAME

The name of the corporation is CALVARY HOLINESS CHURCH, INC.

ARTICLE TWO

PURPOSE

The corporation is organized for the purpose of religious worship, Christian mission and related practices and endeavors.

ARTICLE THREE

NONPROFIT PURPOSE

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code. The corporation is formed exclusively for purposes which are not for profit, and not for pecuniary profit or financial gain. No part of

the corporate assets, income or profits shall be distributable to, or inure to the benefit of its officers, directors or members, except to the extent permitted for a nonprofit corporation under the nonprofit corporation laws of the State of Idaho and Section 501(c)(3) of the Internal Revenue Code. The corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, directors, or members; or promote the private interest of any officer, director or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.

ARTICLE FOUR

DURATION

The period of the duration of this corporation is perpetual.

ARTICLE FIVE

MEMBERS

There shall be one class of members. The conditions and regulation of membership and the rights and other privileges of membership shall be determined and fixed by the By-Laws.

ARTICLE SIX

REGISTERED OFFICE

AND AGENT

The post office address of the corporation's registered office is Route 1, Wilder, Idaho 83676. The initial registered agent at such address is Charlotte Barnes.

ARTICLE SEVEN

DIRECTORS

The number of directors constituting the initial Board of Directors, otherwise known as Board of Trustees, of the corporation is five (5), and the names and addresses

ARTICLE EIGHT

DISTRIBUTION ON DISSOLUTION OR LIQUIDATION

Upon the winding up and dissolution of this corporation,
after paying or adequately providing for the debts and obligations
of the organization, the remaining assets shall be distributed
to a nonprofit fund, foundation or corporation, which has
established its tax exempt status under Section 501(c)(3) of
the Internal Revenue Code.

ARTICLE NINE

AMENDMENTS

These Articles of Incorporation may be amended from
time to time in any manner lawful under the Nonprofit Corporation
Act of the State of Idaho.


