

ARTICLES OF INCORPORATION

YALE MINING COMPANY

of YALE, Idaho.

Know all men by these presents that we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation under the laws of the state of Idaho.

And we hereby certify:

First:- That the name of this corporation shall be the YALE MINING COMPANY.

Second:- That the purpose for which this corporation is organized is to carry on the business of Mining in the state of Idaho, and elsewhere.

Third:- That the principal place of business shall be at this post office, county of Cassia, Idaho.

Fourth:- That the term for which this corporation shall exist shall be fifty (50) years from and after the date of its incorporation.

Fifth:- That the number of directors of this corporation shall be five (5), the names and residences of those appointed for the first year being: F. Coleman Burroughs, Minidoka Idaho; George T. Burroughs Jr., H. S. Burroughs and L. H. Burroughs, of Yale, Idaho; and Walter S. Sparks, of American Falls, Idaho.

Sixth:- The amount of capital stock of this corporation shall be one hundred thousand (\$100,000.00) dollars, divided into one thousand (1000) shares of the par value of one hundred (\$100.00) dollars per share.

Seventh:- The amount of capital stock actually subscribed to this corporation is one hundred thousand (\$100,000.00) dollars. The following are the names of the subscribers: F. Coleman Burroughs, 200 shares, \$20,000; George T. Burroughs Jr., 200 shares, \$20,000; H. S. Burroughs, 200 shares, \$20,000; L. H. Burroughs, 200 shares, \$20,000; Walter S. Sparks, 200 shares, \$20,000.
