### ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

### UNITED AUTO, INC. an Idaho corporation

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is UNITED AUTO, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders and directors of the corporation on the 24th day of December, 1996, in the manner prescribed by the Idaho Business Corporation Act:

The purpose provisions of the Articles of Incorporation, Article II, paragraph a. through d. shall remain the same with the following paragraphs to be added thereafter:

- e. To act as an agent for insurance companies in soliciting, procuring, receiving and forwarding applications for property and casualty, life and accident and health, credit life, and all kinds of insurance, together with the collection of premiums and the doing of such other business as may be designated to agents by insurance companies and to conduct a general insurance agency and insurance brokerage business, and to do any and all things incidental to the operation of an insurance agency which is not forbidden by statute or by these articles of incorporation.
- f. To act as an agent for extended warranty companies in soliciting, procuring, receiving and forwarding applications

for extended warranties on any and all types of motor vehicles, trailers, boats and bicycles, and their parts and accessories, together with the collection of premiums and the doing of such other business as may be designated to agents by extended warranty companies and to conduct a general extended warranty agency/business, and to do any and all things incidental to the operation of a extended warranty agency/business which is not forbidden by statute or by these articles of incorporation.

The remainder of Article II shall remain unchanged.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1000; and the number of shares entitled to vote thereon was 3.

FOURTH: The number of shares of each class entitled to vote thereon as a class voted for and against amendment, respectively, was:
