CERTIFICATE OF AMENDMENTS TO ARTICLES OF INCORPORATION OF SCHAEFER HITCHCOCK COMPANY.

The undersigned Beecher Hitchcock, President, and L. J. Davis,
Secretary, of the Schaefer Hitchcock Company, a corporation, duly organized
and existing under and by virtue of the laws of the State of Idaho, do hereby
certify, as follows:

1. That on the 11th day of February, 1948 at a meeting of the
Board of Directors of the said corporation held at the office of the corporation at Sandpoint, Idaho, all directors being present, by unanimous vote of
the directors of said corporation, Article One of the Articles of Incorporation
was amended to change the name of said corporation from Schaefer Hitchcock
Company to Schaefer-Hitchcock Company; Article Four of the said Articles of
Incorporation was amended to change the existence of the corporation from and
after the date of incorporation from fifty (50) years to perpetual; Article
Five of the Articles of Incorporation of said corporation was amended to
change the number of directors of said corporation from three (3) to not less
than three (3), as may be provided in the By-laws of the corporation. The
articles so amended after amendment to read as follows:

## Article One

The name of said corporation is Schaefer-Hitchcock Company.

Article Four

That the term for which it is to exist is perpetual.

## Article Five

That the number of directors of said corporation shall be as provided in the By-laws of the corporation but shall not be less than three (3).

That all the Shareholders of said corporation representing all of the shares of stock in said corporation issued and outstanding have heretofore consented in writing that said Articles One, Four and Five of said Articles of Incorporation be amended in accordance with the foregoing Articles numbered One, Four and Five as set forth herein and that said written consent by all the Shareholders of the corporation is of record in the Minute Book of said corporation.
