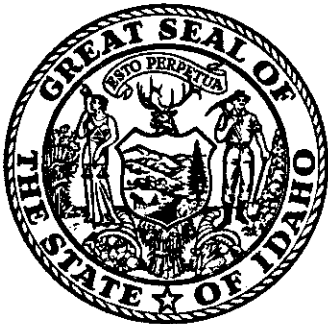

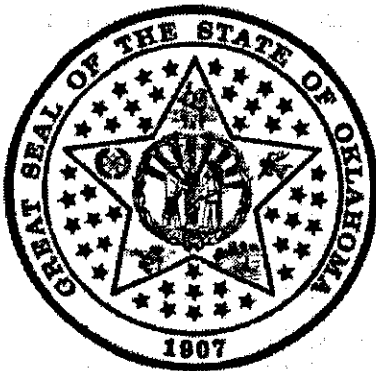


**CERTIFICATE OF NAME CHANGE**
