

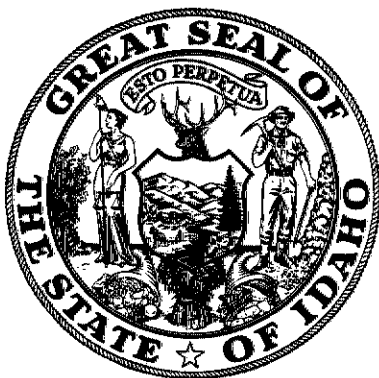
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
Moore Publishing, Incorporated

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons and of full age and citizens of the United States, by these presents associate ourselves together for the purpose of forming a corporation pursuant to the corporation laws of the State of Idaho, and we do hereby certify as follows:

- I. The name of the corporation is Moore Publishing, Incorporated.
- II. The corporation is to have perpetual existence, subject only to dissolution in the manner provided by law.
- III. The purposes for which the corporation is formed are:

To erect, establish, purchase, lease and otherwise acquire, and to hold, sell, manufacture, design, create & produce, copyright and distribute, and generally to conduct the business of Moore Publishing, Incorporated engage in all activities, to render all-services, and to buy, sell, use, handle and deal in all fixtures, equipment, tools, materials, products and merchandise incidental or related thereto or of use therein.

To manufacture, produce, create, copyright and otherwise acquire and trade in and with every kind and description of design, commerical & graphich arts, advanced visual & audio communcations or media and all similar, kindred and allied articles, products, merchandise and services.

To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease real and personal property, to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage or vote, sell, pledge or otherwise dispose of and deal in buying bonds and securities and debentures and other evidence of indebtedness of other corporations, foreign or domestic.

To carry on any other business, whether sales, leasing or otherwise, which may, in the discretion of the Directors, seem capable of being conveniently carried on in connection with the above, or calculated directly or indirectly to enhance the value of the company's property or rights, and to do any and all of the above things, or any part thereof as principals, agents, contractors, or otherwise, and by or through agents or otherwise, and either alone or in conjunction with others, and generally to attain and further any of the purposes herein set forth or incidental to the business of the company, or to any of the powers herein specified; to make, guarantee and perform any contracts of any kind and description, and to do any and all other acts and things and exercise any and all other powers which a co-partnership or natural persons could do, and exercise, and which now or hereafter may be authorized by law.

To exercise all authority conferred upon corporations by Section 30-1-4 of the Idaho Code, and, in addition thereto, to purchase its own stock and to enter it upon its books as treasury stock or to cancel it or re-issue it, and in general to deal and trade in its own stock.

- IV. The aggregate number of shares that the corporation shall have authority to issue is One Thousand Shares, all with no par value.
- V. The address of the registered office of the corporation is 882 Shoup Avenue, Twin Falls, Idaho 83301, and the name of the registered agent at such address is Wesley A. Gates.
- VI. The name and post office address of the initial director named by the below signed incorporator, to serve until the first annual meeting of the shareholders, or until his successor be elected and qualified, is as follows:

- VIII. The private property of the stockholders of the corporation shall not be subject to the payment of the corporation debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation or for any other reason.

- IX. The number of directors of the corporation shall be as specified in the By-Laws, and the number may from time to time be increased or decreased in such a manner as may be prescribed in the By-Laws, providing the number of Directors shall not be less than one.
- X. The Board of Directors is expressly authorized to repeal and amend the By-Laws of the corporation and to adopt new By-Laws, and the corporation reserves the right to amend, alter, change, and repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by law by a majority vote of the shareholders represented in person or by proxy at any annual meeting of the shareholders or at any meeting duly called for that purpose except where the laws of the State of Idaho otherwise provide.
