ARTICLES OF INCORPORATION

Article 1 Name of Corporation

The name of the corporation shall be Idaho State Trapshooters, Inc. The abbreviation IST may be used in these Articles, the Bylaws and any other documents pertaining to this corporation.

Article 2 Purpose

The purpose for which the corporation is organized is to promote the sport of trapshooting in the State of Idaho and to unify the active shooters across the state.

Article 3 Address

Article 4

Board of Directors

The Board of Directors shall consist of seven (7) individuals, to be elected annually from resident members of the organization. Election of these directors shall occur at the annual general membership meeting, to be held in conjunction with the annual State Shoot.

Term limits of three consecutive years apply to these board positions. After serving for three consecutive years, a one year period holding no state position is required.

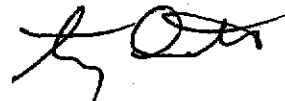

Article 6

Mailing Address

Article 7

Members

The Corporation does have voting members. Upon shooting a registered ATA competition in the state, resident persons automatically become members of the organization. Specific other membership information is written in the Bylaws. Resident ATA life members are also automatic members of the Corporation.

Article 8

Dissolution

Upon dissolution of the corporation, the assets shall be distributed equally to all active members. Active member status is written in the Bylaws.

Article 9

Bylaws

Bylaws of the corporation, consistent with these Articles and with state law, shall be kept current and amended in the means set forth in said Bylaws.

Article 10

Officers

The officers of the corporation shall consist of a President, Vice President, Secretary, Treasurer and Information Director. These officers shall be elected within the Board of Directors in a manner provided for in the Bylaws. Vacancies in any position shall be filled by appointment from the Board of Directors or as stated in the Bylaws. All officers of the corporation shall serve on a voluntary basis. No compensation is allowed.

Article 11

State Shoot

The corporation shall be responsible to hold an annual ATA sanctioned State Shoot at a location, in Idaho, so specified in the Bylaws. It shall be the Board of Directors duty to conduct this shoot, with the host club participating in the actual normal and customary duties of holding a shoot. Compensation shall be given the host club from the corporation to help defray costs incurred. Financial arrangements shall be made between the host club and the corporation at least six months prior to the date of the shoot.

Article 12

Amendments

Proposed amendments to these Articles must be submitted in writing and received by the Secretary no later than January 31 each year. This will provide ample time for notification of all members of pending changes. The proposed amendment will be put on the agenda of the next annual membership meeting, discussed and voted upon then. A two thirds majority vote of the membership present shall be required to amend any part of these Articles.

As adopted March 31, 2011 and as amended from time to time by vote of the general membership.
