ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION

Western Idaho and Eastern Oregon

4-H Club Camp Inc., of Boise

A regular meeting of the shareholders of Western Idaho and Eastern Oregon 4-H Club Camp Inc., of Boise, a corporation, organized and existing under and by virtue of the laws of the State of Idaho, was held at the office of the corporation in Boise, Idaho, on the 13th day of January, 1967, at eight o'clock in the evening of said day, pursuant to a written call and waiver of notice of said meeting signed by the President and Secretary of said corporation.

At said meeting a majority of members of said corporation was present and by affirmative vote amended the Articles of Incorporation of said corporation to change the name thereof to Cascade Lake 4-H Camp Inc., and accordingly Paragraph First of the Amended Articles of Incorporation of Western Idaho and Eastern Oregon 4-H Club Camp of Boise was amended to read as follows:

FIRST

"The name of the corporation is The Cascade Lake 4-H Camp Inc."
