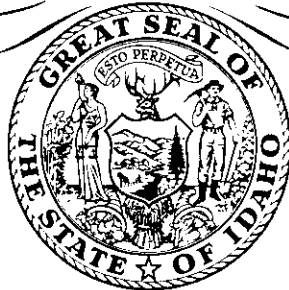

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

HAYDEN LAKE GUN CLUB, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Ninth** day of **November** 19 **65**, original articles of amendment, as provided by Sections 30-146, 30-147 and 30-160, Idaho Code, changing corporate name ~~COEUR D'ALENS GUN CLUB AND TRAP CLUB, INC.~~; changing principal place of business to Coeur d'Alene; extending corporate existence to perpetual; changing number of directors to be not less than **five nor more than nine,** and that the said articles of amendment contain the statement of facts required by law, and are recorded on ~~xxxxxx~~ **microfilm** of Record of Domestic Corporations of the State of Idaho.

AMENDMENT
to
ARTICLES OF INCORPORATION
of
HAYDEN LAKE GUN CLUB, INC.

GAR ANDERSON, JR., president, and WILLIAM P. SCOTT,
secretary, of the above named corporation respectfully show:

That the above named corporation was organized as a non-profit association and sportsman's club, under the laws of the State of Idaho. Thereafter, on November 30, 1955, its authority to do business in the State of Idaho was forfeited because of failure to file annual statement and, on August 31, 1965, submitted an annual statement and paid accrued fees and was reinstated and its corporate rights restored by Corporate Reinstatement Certificate dated August 31, 1965, issued by the Secretary of State of the State of Idaho, copy of which was filed in the office of the Recorder of Kootenai County, Coeur d'Alene, Idaho, on September 15, 1965.

The board of directors of the corporation, at a special meeting of said board held on October 4, 1965, at Coeur d'Alene, Idaho, unanimously adopted the following resolution amending the articles of incorporation, which proposed amendments had been submitted to vote thereon at a special meeting of members on October 4, 1965, at which meeting the following resolution was unanimously adopted:

RESOLVED that the articles of incorporation of HAYDEN LAKE GUN CLUB, INC. be amended in the following respects:

ARTICLE I of said articles shall be amended to read as follows:

The name of this corporation shall be
COEUR D'ALENE SKEET AND TRAP CLUB, INC.

ARTICLE III of said articles shall be amended to read
as follows:

The principal place of business of this corporation
shall be 816 Sherman Avenue, Coeur d'Alene, Idaho, in
care of E. L. Miller.


ARTICLE IV of said articles shall be amended to
read as follows:

The period of existence of this corporation shall
be perpetual.

The first sentence of ARTICLE V of said articles shall
be amended to read as follows:

The government and business affairs of this
corporation shall be managed by a board of directors
of not less than five nor more than nine directors to
be elected by the members. The number of directors
and their terms of office shall be fixed by the by-laws
of the club.
