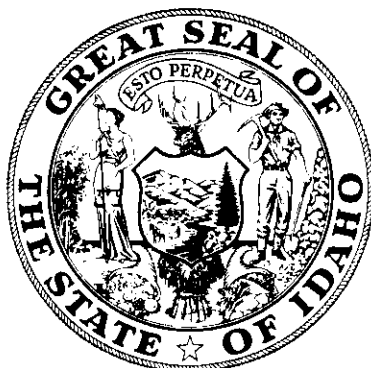

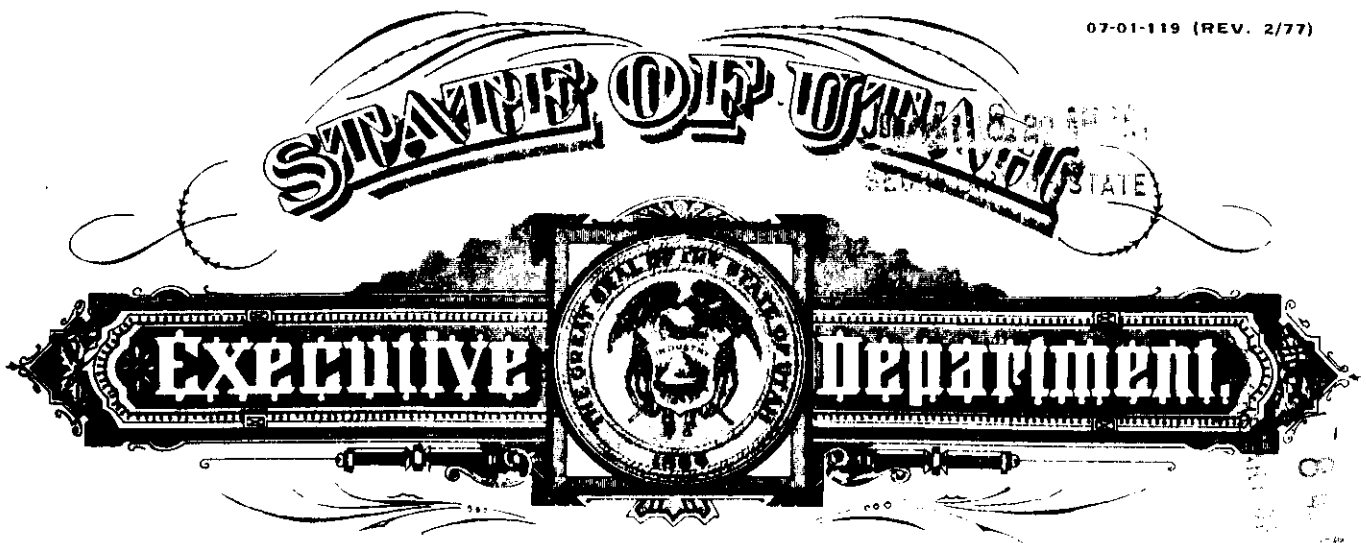

ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporators pursuant to the business corporation act of this state adopt the following articles of incorporation for such corporation:

- FIRST: The corporation name is UNIVERSAL RECOVERY SERVICE, INC.
- SECOND: The period of its duration is perpetual.
- THIRD: The corporation is organized to transact any and all lawful business for which corporations may be incorporated under the laws of this state and to engage in business as a collection agency service.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares, each share having a par value of \$1.00.
- FIFTH: The corporation will not commence business until consideration of the value of at least one thousand dollars has been received for the issuance of shares.
