

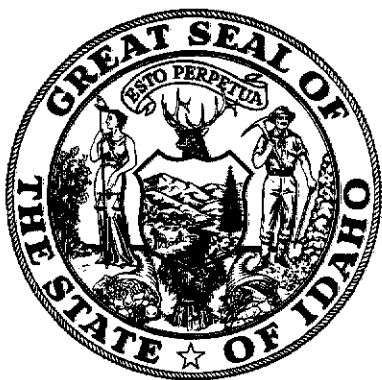
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF

C & P FARMS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is C & P FARMS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 shares in the aggregate amount of \$1.00 per share.

FIFTH: Provisions denying pre-emptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-laws of the corporation, including provision for restriction on transfer of shares, as provided in the Idaho Business Corporation Act, Section 30-1-23A.

SEVENTH: The address of the initial registered office of the corporation is P.O. Box 73, Kuna, Idaho 83634, and the name of its initial registered agent at such address is Carl V. Nicholson.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
