### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, Charles H. Woodward, Allen Noyes, Benjamin I. Cohen and William M. Gregory do make, execute and deliver, in triplicate, articles of incorporation according to the laws of the State of Oregon, as follows:

### ARTICLE I.

The name assumed by this corporation, and by which it shall be known, is "PORTLAND TRUST COMPANY OF OREGON", and its duration shall be perpetual.

### ARTICLE II.

This corporation proposes to engage in the business, pursuits and occupations below set forth, to-wit:

lst - To acquire, purchase, own, hold, use, improve, mortgage, lease, sell and convey, such real estate and personal property, as may be necessary for the convenient transaction of its business, for the safe and profitable investment of its assets, and for the use and occupation of its officers, agents and employes; to purchase any real estate or other property sold at any judicial, tax, or foreclosure sale, or sale under any decree or judgment, or sale in satisfaction of any city lien.

2d -- To take, accept and hold, by the order, judgment or decree of any Court of Record of this State, or of any other State, or of the Courts of Record of the United States, or by gift, grant, assignment, transfer, devise, legacy or bequest from or with any public or private corporation or person whomsoever, any real estate or personal property, upon trusts created in accordance with, or which shall not conflict with, the laws of this State or of the United States, and to execute and perform any and all such legal and lawful trusts in regard to the same, upon the terms, conditions, limitations and rescrictions which may be decclared, imposed, established by, or agreed upon in and by such order, judgment, decree, gift, grant, assignment, transfer, devise, legacy or bequest. To accept and execute for or on behalf of married women, trusts in respect to their separate property, real or personal, and ante-muptial settlements, and otherwise to act as agent for them in the management of such property. To act as agent for the purpose of transferring, issuing, registering or countersigning the certificates of stock bonds, coupons or other evidences of debt of any corporation, association, person, City, County, State, or other authority, or to receive and pay out moneys in redemption of the bonds, coupons or other evidences of indeb-tedness of such public or private corporations or persons.

3d--To take, accept and hold, on deposit or for safekeeping, any and all moneys, bonds, stocks or other securities or personal property, whatsoever, which any State, County, City, town or other officer, or officer in any railroad or other corporation, public or private, or private person, shall be authorized or required by law or otherwise to deposit in a bank or other safe deposit. To receive for safe deposit any valuable property, deeds, wills, mortgages, policies of insurance or other papers, and to execute any instructions with regard thereto that may be given by the depositor, and generally to do all the business suggested by the title of this corporation, in a manner that shall be safe, convenient and satisfactory to its patrons.

4th-To act as Trustee, Assignee in Insolvency or Pankruptcy, Receiver, or assignee in all cases where it shall be lawful for any Court of Record, officer, corporation or person to appoint a trustee, assignee or receiver, and to be a appointed, commissioned and act as administrator of any estate, executor of any last will and testament of any deceased person, and as guardian of the person and (or) estate of any minor, lunatic, imbecile, spendthrift, habitual drunkard or other person disqualified or unable from any cause to manage his estate.

5th-To act as the general or special agent, or attorney in fact, for any public or private corporation or person in the management and control of real estate or other property, its purchase, sale or conveyance, in the negotiation

of and sale of mortgages or other securities, the satisfaction and discharge of record of such mortgages or other securities, the collection of rents, payment of taxes, and generally to act for and represent corporations or persons under powers and letters of attorney or otherwise in all respects as a natural person could do.

6th...This corporation shall have discretionary power to invest all moneys received by it on deposit or in trust, in all cases in which no special directions, as to the class or kind of securities, funds or property, whether real or personal, in which said moneys shall be invested, are contained in the instrument creating the trust, and it shall be held responsible to the owner or cestui que trust or such moneys for the validity, regularity, quality, value and genuineness of all such investments and securities, at the time the said investments are so made, and for the safekeeping of the evidences and securities thereof.

7th...To charge, receive and collect for the faithful performance and discharge of any trust, duty, obligation or service imposed or conferred upon, and accepted by this corporation, such reasonable compensation therefore as the same shall be worth, or such compensation as may have been, or may be fixed by the contract or agreement of the parties, as well as any and all advances and expenses necessarily paid cut and expended in the discharge and performance thereof, and to charge, receive and collect legal interest on such advances or expenses.

8th.—To receive cash deposits on interest, or otherwise, to borrow money for such periods and at such rates of interest as may be agreed on, and to secure repayment of the same to the lender, by issue of promissory notes, bonds, debentures, obligations, or other evidences of indebtedness. To secure payment of its promissory notes, bonds, debentures, obligations or other evidences of indebtedness, by hypothecation, pledge or mortgage of any real or personal assets of the corporation, or by deposit of the same in trust with any trustee for the benefit of the lenders to the corporation, or in trust to secure the payment of its promissory notes, bonds, debentures, obligations or other evidences of indebtedness.

9th—To loan money or funds, either as principal, for its own benefit, or as agent or trustee for other persons or corporations; and to take, as security for such loans, mortgages, deeds of trust, or other liens, pledges, or hypothecations of real estate or personal property, and to sell, assign or convey such mort—gages, deeds of trust, liens, hypothecations or pledges, or convert them into cash or other securities.

10th...To become surety upon the bond or undertaking of any person or corporation, required by the laws of thisState to execute a bond or undertaking, or procure such bond or undertaking from other corporations or individuals.

llth.-Whenever, in the performance or discharge of any trust, duty, obligation or service which shall have been, or may be imposed on this corporation, or accepted by it, it shall become necessary to give or furnish any bond or undertaking of sumetyship, or to become surety for any individual or corporation for the proper performance of said trust, duty, obligation or service, this corporation may give its own bond or undertaking of suretyship or guaranty, or may procure bonds or undertakings from other corporations or individuals, conditioned according to law to guarantee or ensure the proper performance of said trust, duty, obligation or service.

12th.To insure titles to real estate and mortgages thereof, with a guaranty against loss arising from mistake or fraud, hidden defects, decedents' debts, conflicting surveys, forged deeds or wills, undiscovered incumbrances, mechanics' or city liens, omission in the chain of title of an unknown husband, wife, or heir, or with other guaranty as to the soundness or validity of such title.

This corporation shall not engage in any banking, merchantile, manufacturing or other business, except such as is hereby expressly authorized. It shall not loan its funds, moneys, capital, trust funds or other property whatsoever, to any director, officer, agent or employe hereof, nor shall any such director, officer, agent or employe become in any manner indebted to this corporation, by means of any over-draft, promissory note, account, endorsement, guaranty or other contract whatsoever, save and except subscriptions to the capital stock, and such bonds as may be required from any such director, officer, agent or employe for the faithful performance of his duties, as such.
