

Know all men by these presents
that we L. L. Burtershaw F. E. Brown
Miss Mand. Peters and Mrs. Alice Piper
of the Town of Council in the County of
Washington and State of Idaho, hereby asso-
ciate ourselves together, for the purpose,
of forming a religious Corporation
under the laws of the said State of Idaho,
and to that end do hereby Certify.

— First —

That the name assumed by this Corporation
and the name by which it shall be known is
The Congregational Church of Council.

— Second —

That the purpose for which said Corpo-
ration is formed, is to establish and maintain
a Church for the purpose of the worship
of God according to the rites, Canons, disci-
pline, usages, customs, creeds and Articles of
faith of the Congregational Church, and
to have use and enjoy real personal and
mixed property for Church purposes
and to acquire the same by gift donation
or purchase

— Third —

That the place where the principal business
is to be transacted, and where said Church is
to be located is the Town of Council in
the County of Washington State of Idaho,

— Fourth —

That the term for which said Corporation is to exist is fifty years.

— Fifth —

That the number of trustees of said Corporation is four, and the names and residence of those appointed for the first year are as follows, "to-wit"

— Sixth —

That there is no Capital Stock of said Corporation, and there are no shares therein, and that said Church is supported entirely by voluntary Contribution and Subscription.

— Seventh —

That, prior to the date hereof, to-wit on the 11th day of August, 1901, a meeting was held for the purpose of electing trustees or directors, for said Corporation, the said Meeting was held at the School house in the said Town of Council, the same being the usual place of meeting of said Church and that at such meeting, a majority of the

members of said Church were present and
voted at such election, and that as a result
of such election, the said L. L. Burtenshaw
F. E. Brown, Miss Maude Peters, and Mrs. Alice
Piper were elected as trustees of said
association for the period of one year
from said date and until their successors
are elected and qualified, which facts of
election were duly verified by the officers
who conducted said election
