KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned incorporator, being a natural person of full age and a citizen of the United States of America, in order to

form a corporation for the purposes hereinafter stated, under and pursuant to the Idaho Business Corporation Act and the Idaho Professional Service Corporation Act, and such other laws of the State of Idaho as are pertinent, and do hereby certify as follows:

1. NAME:

2. DURATION:
