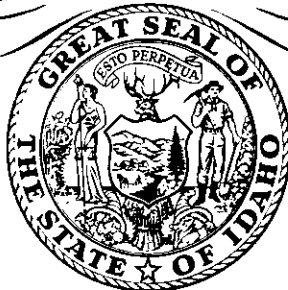

ARTICLES OF INCORPORATION
OF
BURLEY REMINDER, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all natural persons of legal age and all citizens of the United States and all residents and citizens of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

1.

The name of the corporation is Burley Reminder, Inc.

2.

That the said corporation is formed for the following purposes:

- a. To conduct a general commercial printing and advertising business both as principals and agents including the preparation and arrangement of advertisements, the manufacture and construction of devices and novelties to carry on the business of commercial printers, publishers, and decorators in connection with the advertising business, to make and carry out contracts of every kind that may be necessary for the accomplishment of the commercial printing and advertising purposes of the company, to carry on the business of printers, engravers, book printers, account book manufactures including all kinds of printing and off-set printing, to lease, buy, hold, and sell all property real or personal that may be necessary to the prosecution of said business.

- b. to own, buy sell, develop, lease and manage business of any and all varieties and business properties of any and all varieties and to engage in all activities incidental thereto.
- c. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and indentures and other evidences of indebtedness of its own and of other corporations, domestic or foreign.
- d. To conduct business in this state, other states, District of Columbia, territories and colonies of the United States and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situated out of this state.
- e. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of obtaining or furthering any of its business.

- f. To enter into, make perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.
- g. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

3.

To corporation is to have a perpetual existence.

4.

The location and post office address of the registered office of said corporation is Burley, Cassia County, Idaho.

5.

The capital stock of said corporation shall be Two Hundred Fifty Thousand Dollars (\$250,000.00) to be represented by Twenty-Five Hundred (2,500) shares of stock to be of the denomination of One Hundred Dollars each (\$100.00). All of said stock issued by said corporation shall

be common capital stock and be of the par value of One Hundred Dollars (\$100.00) per share, and all of said stock shall be voting stock.
