ARTICLES OF INCORPORATION

OF 94 MAR 16 AM 8

NORTH CALDWELL CONGREGATION OF JEHOVAH'S WITNESSES, INC.

We, the undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation is NORTH CALDWELL CONGREGATION OF JEHOVAH'S WITNESSES, INC..

ARTICLE II

DURATION: The period of its duration is perpetual.

ARTICLE III

PURPOSES: The purposes for which the corporation is organized are:

To provide for a proper place of worship and to maintain such place of worship for the benefit of Jehovah's Witnesses among the population of the City of Caldwell, State of Idaho, more particularly in that portion of the city known as North Caldwell and those who desire to attend such worship conducted by Jehovah's Witnesses in said area and in surrounding areas to learn the truths of the faith and belief of Jehovah's Witnesses, based upon the Bible, the written word of Almighty God, Jehovah; and to take by gift, legacy or bequest, and to purchase, lease, hold, sell, convey, acquire, mortgage, manage, dispose of and deal in real estate and personal property in any manner that may seem proper and best for the welfare of the congregation.

ARTICLE IV

DIRECTORS: The number of directors constituting the initial board of directors of the corporation is three and the names and addresses of the persons who are to serve as directors until their successors are elected and shall qualify are:

19 The corporation will have members as provided in its

21 ARTICLE VIII

22 In the event of the dissolution of this corporation,
23 the assets thereof shall not inure to the benefit of any in-
24 dividual, whether director officer, or member of this corpora-
tion, but upon any such dissolution the assets of this corpora-
tion shall only be transferred to another incorporated congrega-
tion of Jehovah's Witnesses or to the central organization of the
congregation, to-wit, WATCHTOWER BIBLE AND TRACT SOCIETY OF NEW

1 YORK, INC., a non-profit corporation, provided such organizations
2 have qualified under Section 501(c)(3) of the Internal Revenue
Code.

4 ARTICLE IX

5 No director, officer or member of the corporation shall
6 be personally liable for any of the debts, liabilities or
obligations of the corporation.

8 ARTICLE X

9 This corporation is organized exclusively for and will
10 be operated exclusively for religious purposes; no part of its
net income will inure to the benefit of any private shareholder
11 or individual; no substantial part of the activities of the
corporation shall be the carrying on of propoganda, or otherwise
12 attempting to influence legislation; and the corporation shall
not participate in, or intervene in, any political campaign on
13 behalf of or in opposition to any candidate for public office.


