I, JAS. H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

COLLISTER BUILDERS. INC.

was filed in the office of the Secretary of State on the 23rd day of April A. D. One Thousand Nine Hundred Fifty-eight and is duly recorded on Film No. 102 of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for

fifty years from the date hereof, with its registered office in this State located at

and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

Articles of Incorporation

of the

COLLISTER BUILDERS, INC.

all full-age citizens of the United States, KNOW ALL MEN BY THESE PRESENTS, That the undersigned, under and by virtue of the provisions of Chapter 10, Title 30, of the Idaho Code and any amendments thereto relating to corporations not for pecuniary profit, have associated ourselves and do hereby incorporate ourselves as a body corporate with all the rights and privileges granted by the laws of the State of Idaho, and do hereby adopt Articles of Incorporation, as follows:

ARTICLE I

Section 1. The name of this corporation is and shall be, Collister Builders, Inc., with its principal place of business at Boise, Ada County, Idaho.

ARTICLE II

Section 1. The purpose of this corporation shall be to advance the agricultural, commercial, industrial, residential and civic interests of the Collister area of metropolitan Boise and adjacent territory; and to advance the general welfare and prosperity of said area.

Section 2. This corporation in its activities shall be nonpartisan, nonsectional and nonsectarian.

ARTICLE III

Section 1. The corporation may acquire, take by gift, purchase, devise or bequest, real and personal property for purposes appropriate in the exercise of its powers, and may lease, mortgage, and dispose of real and personal property, including the right to take, hold and dispose of shares of stock in other corporations.

ARTICLE IV

Section 1. The corporate existence of this corporation shall be limited to a term of fifty (50) years from the date of its incorporation.

ARTICLE V

Section 1. The government of the corporation shall be vested in a Board of Directors, who shall be members of the corporation, and such officers and committees as said Board of Directors may appoint in conformity with these articles and with the by-laws of this corporation. The Board of Directors shall consist of not more than fifteen nor less than nine members, who shall be nominated and elected in the manner prescribed in the by-laws of this corporation.

Section 2. The officers shall be a president, vice-president, secretary and treasurer.

ARTICLE VI

Section 1. The members of the corporation shall adopt, amend or repeal all by-laws required for the management of its affairs.

ARTICLE VII

Section 1. All persons, corporations or associations who may pay the annual dues prescribed by the by-laws of this corporation shall, by virtue of such payment, be members of this corporation.

Section 2. Pecuniary profit shall not be the object of this corporation, and the rights and privileges of all members in good standing shall be equal, including the right to vote, and no member shall have or acquire a greater interest therein than any other member.

ARTICLE VIII

Section 1. These articles of incorporation may be amended by a vote of two-thirds of the members in good standing in attendance at any regular meeting, or at any special meeting called for that purpose, provided that such proposed amendments shall be plainly stated in the call for the meeting at which they are to be considered.

ARTICLE IX

Section 1. The private property of the members of this corporation shall not be liable for the debts of this corporation, but shall be wholly exempt therefrom.
